A RESOLUTION ADOPTING A STATEMENT OF SERVICES AND A STATEMENT REGARDING POSSIBLE INCOMPATIBLE LAND USES AND ZONING BUFFER FOR A PROPOSED ANNEXATION OF ±07.389 ACRES FROM WALNUT TOWNSHIP TO THE VILLAGE OF THURSTON AND DECLARING AN EMERGENCY

WHEREAS, a petition for an Expedited II method of annexation of ± 7.389 acres from Walnut Township was filed with the Board of County Commissioners of Fairfield, Ohio on February 9, 2015 by Thomas L. Hart, attorney and agent for Petitioners Laura and Max Miller; and

WHEREAS, R.C. 709.023(C) requires that, within twenty days of an annexation petition being filed, the municipal authority shall adopt a statement of services indicating which services the municipal corporation will provide to the territory proposed for annexation and an approximate date by which it will provide services to the territory upon annexation; and

WHEREAS, R.C. 709.023(C) requires that, within twenty days of the annexation petition being filed, the municipality to which annexation is proposed must adopt an ordinance or resolution relating to land uses and buffers if the territory proposed to be annexed is currently subject to either county zoning pursuant to Chapter 303 or township zoning pursuant to Chapter 519 of the Ohio Revised Code; and

WHEREAS, R.C. 709.023(C) defines "buffer" to include open space, landscaping, fences, walls, and other structured elements, streets and street rights-of-way, and bicycle and pedestrian paths and sidewalks; and

WHEREAS, the total perimeter of the proposed annexed territory is approximately 10,832.48 feet, of which 560.07 feet is contiguous with the Village, giving 5.17% contiguity, and the Village is adjacent to said territory primarily to the south and east of the territory.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF THURSTON, OHIO THAT:

- SECTION 1. The Village of Thurston will provide the following municipal services for the ±7.389 acres, subject territory currently in Walnut Township (Fairfield County) immediately upon the annexation of the area to the Village of Thurston, Ohio:
 - (a) <u>Fire and EMS</u>. The Thurston-Walnut Fire Department will provide, cause to provide, or contract to provide fire protection and EMS services to the annexation area at the same or similar level now being provided to other areas of the Village with similar land use and population.
 - (b) <u>Potable Water Service</u>. Once the Village of Thurston's water treatment plant is fully functional and available to all Village residents and businesses, the Village of Thurston will provide, cause to provide, or contract to provide potable water service to the annexation area at the same or similar terms being provided to other areas of the Village with similar land use and population.
 - (c) <u>Solid Waste Collection</u>. Residential refuse collection services are contracted by the Village and are currently provided by Local Waste Services, Ltd.
