Budget for the next succeeding fiscal year commencing January 1<sup>st</sup>, 2017; and*

*WHEREAS, the Budget Commission of Fairfield County, Ohio, has certified its action thereon to  
this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied  
by this Council, and what part thereof is without, and what part within, the ten mill limitation; therefore, be  
it*

*RESOLVED, By the Council of the Village of Thurston, Fairfield County, Ohio, that the amounts  
and rates, as determined by the Budget Commission in its certification, be and the same are hereby  
accepted' and be it further*

*RESOLVED, That there be and is hereby levied on the tax duplicate of the Village of Thurston the  
rate of each tax necessary to be levied within and without the ten mill limitation as follows:*




