**SECTION 1:** That in order to provide for the payment of the current expenses and other expenditures of the Village of Thurston during the first quarter of the fiscal year 2021, ending on March 31, 2021, the following sums be and are hereby appropriated as follows:

**SECTION 3:** For the reason noted in the preamble, this resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and general welfare of the citizens of Thurston, Ohio. Therefore, this resolution shall become effective immediately upon its passage by Council.


